On the recommendations of the Committee for fixation of Fee Structure of Professional Colleges, sanction is hereby accorded to the notification of following revised fee structure in respect of different courses undertaken in ASCOMS, Sidhra, Jammu:-

**A) MS/MD courses**

No. of seats	Existing Fee Structure	Revised Fee Structure
09 seats of Government quota	Rs.9,00,000/- (Rupees Nine lacs) per student per year	Rs.12,15,000/- (Rupees Twelve lacs & Fifteen Thousand only)
07 seats of Management quota	Rs.9,00,000/- (Rupees Nine lacs) per student per year	Rs.12,15,000/- (Rupees Twelve lacs & Fifteen Thousand only)
02 NRI seats to be filled by Management	US Dollars 21750 (Twenty One Thousand Seven Hundred & Fifty) per student per year	US Dollar 26317 (Twenty Six Thousand & Three Hundred & Seventeen)

The revision is subject to the stipulation that ASCOMS will pay stipend to the PG students of all the three categories at par with the stipends being paid to the PG students in the State Government Medical/Dental Colleges in terms of Government Order No.597-HME of 2017 dated 25.10.2017.

10 seats reserved for weaker section of society for MBBS course	Rs.39,000/- (Rupees Thirty Nine Thousand) per student per annum	Rs.42,900/- (Rupees Forty Two Thousand & Nine Hundred only)
10 seats of NRI category	US Dollar 19565 (Nineteen Thousand, Five Hundred & sixty Five only)	US Dollar 21522 (Twenty One Thousand, Five Hundred & Twenty Two only)

The revised Fee Structure for MBBS course shall be applicable for academic session 2019-20 & onwards and for MS/MD courses, it shall be applicable for the academic session 2020-21 onwards.


